The Director of Internal Audit is responsible for the leadership, direction and oversight of the internal audit function of the South Carolina Department of Transportation (SCDOT), a state agency with an operating budget of approximately \$1.6 billion. Reporting to the State Auditor, the Director is responsible for managing and developing a team of audit professionals and is heavily involved in implementing auditing strategy as well as supporting the State Auditor in leading the audit function at SCDOT. This position oversees the annual risk assessment and the development of an audit plan which assists SCDOT governance and senior leadership in assuring that operations are managed to an appropriate level of risk, while making certain the mission and objectives of the agency are accomplished.
